REVERSE TRANSFOR MEMORANDUM OF UNDERSTANLING BETWEEN THE UNIVERSITY OF SOUTH FLORIDA SAR ASOTA-MAN ATEE AND

STATE COLLEGE OF FLORIDA,

This Agreement is entered in to by and between The University of South Florida Board of Trustees, a public body corporate of the State of Florida ("University"), on behalf of the University of South Florida Saras et a Manatee, located in Saras et a County and Manatee County, Florida ("US FSM") and State Collegia of Florida, Manatee-Sarasa ta, 5840 26th Street West, Bradenton, Florida 34207("SCF").

WHI REAS, on May 2, 2013 the Presidents of USF and CP, and the Regional Chancellor of USFSM met to devel p strategies to expand access, to meet extra ordinary demands for growth and to provide for a competitive workforce in the Tampa Bay region; and

WHI REAS, the parties agreed to establish an alignment of inter-institution systems, policies and procedures for the revertes transfer of coursework from USFSM to SCF, for students who did not complete their Associates of Arts (AA) degree to fulfill requirements at SCF so students will earn the AA from SCI and

WHEREAS, this ACREEMINT will outline further how the parties will implement the reverse transfer from USFSIM to SCAP to allow students to graduate with an AA

NOV/ THEREFOR E, in consideration of the premises, the mutual covenants and agreements contained hereinafter, the adequacy of which is hereby acknowledged, the parties do agree as follows:

 - Identify domestic stullents who transferred to USI SM prior to the completion of their Associate degree: at the SCF.
 - F. Provide USFSM writt timely and accurate information for those students who will be able to meet Associate degree requirements at USFSM each term.
 - Collaborate with US SM Registrar to exchang a sudent records.
 - I). Confer the Associate Degree.
 - E. Communicate with U SFSM students who have met Associate degree requirements to in sure they are aware of the posting of their degree.

- F. Provide students with informat in about the conferral, convocation, and commencement information as ociated with award of the Associate degree.
- G. Recognize and accept any partrering institution's declaration of completion of General Education requirement.

- A. Provide access to student acade aic records for those students requested by the SCF.
- B. Upon ε dmission to USFSM with a minimum of 15 credits earned from SCF, USFSM will make students aware of the AGREEMENT as outlined in this AGREEMENT.
- C. Provide SCF with updated and a curate student directory/contact information.
- D. Ensure continuous communication and liaison between the USFSM and SCF in support of these reverse transfer init atives.

The parties acknowledge that the program involves degree-seeking students taking part in a degree program. Therefore, in the event of expiration or either party ter ninating this Agreement, oth parties agree that they will cease accepting new students into the program up in termination, but shall use best efforts to provide a "teach-out" for students. The parties agree they will continue to fulfill each of their respective obligation as set forth in this Agreement for all students that have enrolled and/or been ac hitted to the program prior to termination, from the time of termination through ea h student's successful completion of their degree, certificate of course, or each student's departure from the program.
